GRAPEVINE RELIEF AND COMMUNITY EXCHANGE (GRACE) IS AN ORGANIZATION THAT PROVIDES EMERGENCY ASSISTANCE, BASIC HEALTHCARE SERVICES, AND TRANSITIONAL HOUSING TO "INDIVIDUALS AND FAMILIES IN CRISIS AND GUIDANCE TOWARD SELF-SUFFICIENCY."

EMERGENCY ASSISTANCE - INDIVIDUALS AND FAMILIES SEEKING RELIEF FROM FINANCIAL CRISIS OR WHO ARE OTHERWISE AT-RISK OF BECOMING HOMELESS CAN FIND AID THROUGH EMERGENCY ASSISTANCE. AS THE SINGLE POINT-OF-ENTRY TO ALMOST ALL GRACE SERVICES, CASEWORKERS IN EA CONDUCT INDIVIDUAL AND FAMILY NEEDS ASSESSMENTS. TO STABILIZE FAMILIES AND PUT THEM ON THE PATH TO SELF-SUFFICIENCY, CASEWORKERS HELP THEM OBTAIN SAFETY, FOOD, CLOTHES, AND SHELTER UTILIZING RESOURCES PROVIDED THROUGH EA. CLIENTS MAY RECEIVE FINANCIAL ASSISTANCE UP TO FOUR TIMES PER YEAR FOR ASSISTANCE WITH ISSUES SUCH AS RENT AND UTILITY PAYMENTS OR GAS VOUCHERS. THIS YEAR, GRACE PROVIDED \$536,731 IN FOOD AND 222,641 IN CLOTHING IN ADDITION TO \$172,871 IN RENT AND UTILITY ASSISTANCE THAT SAFEGUARDED 703 FAMILIES FROM HOMELESSNESS.

TRANSITIONAL HOUSING - THE PROGRAM PROVIDES LONG-TERM ASSISTANCE AND CASE MANAGEMENT FOR HOMELESS INDIVIDUALS AND FAMILIES WILLING TO WORK TOWARD BECOMING SELF-SUFFICIENT. CASE MANAGEMENT APPOINTMENTS ARE CONDUCTED WEEKLY AND VOLUNTEER CASE AIDS ASSIST WITH DAY-TO-DAY FUNCTIONING. THIS PROGRAM INCLUDES HOUSING AND BASIC NEEDS BASED ON THE CLIENTS PROGRESS TOWARDS SELF-SUFFICIENCY. THE PROGRAM IS AVAILABLE TO THE FAMILIES FOR A MINIMUM OF SIX MONTHS AND A MAXIMUM OF TWO YEARS.

MEDICAL SERVICES - THE OUTREACH TO HEALTH MEDICAL CLINIC PROVIDES MEDICAL CARE AND PRESCRIPTIONS TO GRACE CLIENTS WITH NO HEALTH INSURANCE AND MARGINAL MEANS TO ACCESS CARE ELSEWHERE. VOLUNTEER MEDICAL PROFESSIONALS PROVIDE GENERAL PRACTICE SERVICES AT THE CLINIC; REFERRALS ARE MADE FOR CLIENTS NEEDING SPECIALTY TREATMENT. WELL- WOMAN CLINICS PROVIDED THROUGHOUT THE YEAR PROVIDE EDUCATION, SCREENING, AND TESTING; A MONTHLY DIABETIC EDUCATION PROGRAM ALSO PROVIDES ONGOING CARE FOR DIABETIC PATIENTS AS WELL AS EDUCATIONAL SEMINARS FOR CLIENTS AND THE PUBLIC. AS GRACE HAS GROWN AND ADJUSTED TO THE NEEDS OF PATIENTS, PROGRAMS, SUCH AS A SPECIALTY CARDIOLOGY AND EPILEPSY CLINIC, HAVE BEEN ADDED. THE CLINIC IS A MEMBER OF THE TEXAS ASSOCIATION OF CHARITABLE CLINICS.
